Please note that you can appoint a proxy (of a paid member) to vote on your behalf if you cannot attend the meeting. There will not be a set determined number of members, to ensure that the meeting has a quorum and can go ahead on the planned date, as this will be the founding meeting. You can appoint a proxy by completing the attached Proxy form, having it duly signed and forwarding to Longacres.Equestrian.Assoc@gmail.com

A General item has been included on the Agenda. This allows members the opportunity to include general matters on the Agenda, prior to the meeting that they wish to be discuss at the Founding Meeting. In order to ensure that everyone is prepared to discuss these matters, it is required that you submit your item for the General Agenda Item no later than 18hoo on Wednesday, 7<sup>th</sup> May 2021 in order for these items to be included in the agenda and allow for any necessary preparation that may be required.

#### Additional Note

- Membership to the Association is completely voluntary i.e. all Longacres Estate Home Owners will **not** automatically be a member of the Equestrian Association.
- 2. An initial membership fee of R200 per year has been set for payment, on or before the Founding Meeting on the 8<sup>th</sup> May 2021. If you are not a paid member you can not be nominated or be eligible to serve as a trustee or a committee member, of the Equestrian Association.
- 3. The membership is not restricted to horse owners exclusively, any property owner, tenant or livery client may be a paid member, please read Section 5 of the constitution for the description of membership.
- 4. Every paid up member will be eligible to vote (with certain restrictions).
- 5. HOA Members, under 18 years of age, (dependents of HOA members) are encouraged to join, the only proviso would be voting related to the HOA open space and related property matters, would rest with the HOA member. This also applies to Associate Members.
